DETERMINING “THE RIGHT TIME” FOR HOSPICE & PALLIATIVE CARE

Hospice and other palliative care providers are often frustrated when providers refer a patient late in the patient’s disease process. These referrals come so late that hospices are left with only days, if not hours, to do what needs to be done for the patients and families in their care.

Asking providers to predict the mortality of their patients can be fundamentally unfair. First, they have been doing everything they can to delay that death, so making mortality predictions runs counter to what they have been focused on. Second, they likely have never received any clinical training on how to estimate prognosis. Third, providers are trained to always think of the next intervention, and with that mindset, the option of looking away from curative interventions is nothing short of counterintuitive.

All of this leads to clinicians vastly overestimating a patient’s life expectancy and missing the appropriate timing for a hospice or palliative care intervention. Given all of the roadblocks facing hospice and palliative care, what can be done to ensure that patients are referred for the proper care at the proper time?

DATA GUIDED DECISIONS
